### SECTION 5: Handling and storage

**Additional hazards when processed** : Handle empty containers with care because residual vapours are flammable.  
**Precautions for safe handling** : Ensure good ventilation of the work station. Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Provide good ventilation in process area to prevent formation of vapour. No open flames. No smoking. Take precautionary measures against static discharge. Use only non-sparking tools. Avoid breathing smokes, vapours. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Ground/bond container and receiving equipment. Flammable vapours may accumulate in the container. Use explosion-proof equipment. Wear personal protective equipment. Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Avoid contact with skin and eyes.  
**Hygiene measures** : Wash hands thoroughly after handling. Contaminated work clothing should not be allowed out of the workplace. Wash contaminated clothing before reuse. Do not eat, drink or smoke when using this product. Always wash hands after handling the product.  
**Technical measures** : Proper grounding procedures to avoid static electricity should be followed. Ground/bond container and receiving equipment. Use explosion-proof ventilating equipment.  
**Storage conditions** : Keep only in the original container in a cool, well ventilated place away from : Heat sources, Direct sunlight. Keep container tightly closed. Store in a well-ventilated place. Keep cool. Store locked up.
